

Chairperson of the Committee on the House of Representatives Affairs as a representative of the government whip disclosed the results of the 4<sup>th</sup> meeting of the Joint Coordinating Committee of the House of Representatives of the year 2021

On Tuesday 6<sup>th</sup> July 2021, at 13.20 hrs., at press room, 1<sup>st</sup> floor, Parliament Building, Hon. Mr. Anan Pholamnuay, Chairperson of the Committee on the House of Representatives Affairs, as a representative of the government whip made a statement on the results of the 4<sup>th</sup> meeting of the year 2021 of the Joint Coordinating Committee of the House of Representatives which was chaired by Hon. Mr. Suchart Tancharoen, First Deputy Speaker of the House of Representatives, in order to consider the guidelines of the meetings of the House of Representatives under the Coronavirus Disease 2019 (COVID-19) pandemic situation. The meeting resolutions were as follows:

1. On 7<sup>th</sup> July 2021, there would be the meeting of the House of Representatives regularly due to the considerations of the important laws were pending;

2. All Committees and the related Ad-hoc Committees were demanded for the cooperation of the meeting suspension for 2 weeks if no necessity. The Ad-hoc Committee on Annual Budget Appropriations Bill B.E. 2565 and 9 Sub-Committees associated to appropriations are able to call the meetings because of the necessity to complete the process within the specific timeframe, but the reduction of meeting participants and followers as less as possible would be requested, and they must strictly follow the public health measures;

3. For more safety, all MPs must be detected the infection with the rapid test kits in order to test the infection provided by the Secretariat of the House of Representatives. If the infection results were found, the Secretariat of the House of Representatives must provide the further measures to take care of the infected MP;

4. The Secretariat of the House of Representatives was requested to conduct the vaccinations for all parliamentary staff and related persons. The meeting also recommended the Secretariat of the House of Representatives to provide the booster dose vaccine (the 3<sup>rd</sup> dose) to the parliamentary staff and related persons to reboost their immunity continuously.

Currently, there were only 15 MPs who had not been vaccinated due to the congenital diseases of vaccinated prohibition.
