The 12th Session of the 25th House of Representatives Meeting, 3rd Year (Second Annual Ordinary Session)









On 2nd December 2021, at the House of Representatives Chamber, 2nd Floor, Parliament Building, H.E. Mr. Chuan Leekpai, Speaker of the House of Representatives, presided over the 12th session of the 25th House of Representatives meeting, 3rd year (second annual ordinary session). On this occasion, Hon. Mr. Suchart Tancharoen, First Deputy Speaker, and Hon. Mr. Supachai Phosu, Second Deputy Speaker, served as the Chairperson of the meeting in rotation.

The meeting agreed to consider a motion following the 9^{th} session of the 25^{th} House of Representatives Meeting, 3^{rd} year (second annual ordinary session) on 25^{th} November 2021, as follows:

- 1. The request for the House allowance to establish the Ad-hoc Committee to consider the opening of Entertainment Complex in order to obtain the new source of national income from foreign tourists;
- 2. The request for the House allowance to establish the Ad-hoc Committee to consider the control and regulation of illegal gambling in Thailand;
- 3. The request for the House allowance to establish the Ad-hoc Committee to consider the opening of Entertainment Complex in the Northern Special Economic Zone (NEC) in order to obtain the new source of national income;
- 4. The request for the House allowance to establish the Ad-hoc Committee to consider the problem of the wide spread of electric gambling machines (slot machine) in order to prevent the emerge of source of evil in the community;
- 5. The request for the House allowance to establish the Ad-hoc Committee to consider the issue of online gambling in order to prevent people's problems and social crime;
- 6. The request for the House allowance to establish the Ad-hoc Committee to consider the collection of revenue from the casino business and any forms of gambling to solve people's debts;
- 7. The request for the House allowance to establish the Ad-hoc Committee to consider the inclusive prevention and solution of the wide spread of electric gambling machines (slot machine);
- 8. The request for the House allowance to establish the Ad-hoc Committee to consider the opening of Urban Entertainment Complex in Hua Hin District, Prachuap Khiri Khan Province;
- 9. The request for the House allowance to establish the Ad-hoc Committee to consider the legal opening of casino;
- 10. The request for the House allowance to establish the Ad-hoc Committee to consider the opening of Entertainment Complex to increase the national income and community based tourism;

11. The request for the House allowance to establish the Ad-hoc Committee to consider the

opening of Entertainment Complex to search for the new source of income from foreign tourists;

12. The request for the House allowance to establish the Ad-hoc Committee to consider the control, organizing, and legalizing of the illegal gambling and online gambling for taxation

system as the national income.

The member of the House of Representatives who was the motion mover made the

conclusion, then, with 310 votes in favor, the meeting resolved to approve the House of

Representatives to establish the Ad-hoc Committee to consider the opening of Entertainment

Complex to find new sources of income from foreign tourists entering the country consisted of

60 members with a 90 - day period for consideration.
