On 19<sup>th</sup> January 2022, at the House of Representatives Chamber, Parliament Building, H.E. 3. Draft Bill on Student Loan Fund (No. ..), B.E. .... (proposed by the Council of Ministers) The sitting agreed to take the following 4 similar draft bills into consideration together.
