The 16th Session of the 25th House of Representatives, 3rd Year (Second Annual Ordinary Session)



On 15th December, 2021, at the House of Representatives Chamber, 2nd Floor, Parliament Building, H.E. Mr. Chuan Leekpai, Speaker of the House of Representatives, chaired the 16th Session of the 25th House of Representatives, 3rd Year, (Second Annual Ordinary Session) with Hon. Mr. Suchart Tanjaroen, First Deputy Speaker of the House of Representatives, and Hon. Mr. Supachai Phosu, Second Deputy Speaker of the House of Representatives, served as the Chair of the sitting in rotation.

Matter informed the sitting by the President

1. The House of Representatives announcement on the elevation of the next person whose name on the list of that political parties to become Member of the House of Representatives, as the replacement of vacancy, were as follows: 1) Hon. Mr. Torsak Asavahame replaced Hon. Mr. Buddhipongse Punnakanta; and 2) Hon. Mr. Chakphan Piyapornphaiboon replaced Hon. Mr. Isara Somchai and both of them took an oath of office at the sitting.

Matter reviewed by the Committee

1. Amending of the Orders of the Head of the National Council for Peace and Order Bill, No. 19/2560, on the issue of regional area educational reform of the Ministry of Education, dated 3 April, B.E. 2560.

After the sitting discussion concerning the Bill, the sitting agreed to accept the request of the Committee to withdraw their proposed Bill for their further considerations.

Pending matters were as follows:

1. Repeal of the Announcements and the Orders of the National Council for Peace and Order and the Order of the Head of the National Council for Peace and Order that are in violation of Human Rights and Democratic Principles Bill, B.E.

With 234 votes in favor, the sitting resolved to disagree in principles of the Repeal of the Announcements and the Orders of the National Council for Peace and Order and the Order of the Head of the National Council for Peace and Order that are in violation of Human Rights and Democratic Principles Bill, B.E.

2. Repeal of the Announcement of the National Council for Peace and Order and the Orders of the Head of the National Council for Peace and Order Bill, B.E.

With 229 votes in favor, the sitting resolved to disagree in principles of the Repeal of the Announcement of the National Council for Peace and Order and the Orders of the Head of the National Council for Peace and Order Bill, B.E.

3. Amending the Criminal Procedure Code Bill (No. ..)

With 236 votes in favor, the sitting resolved to agree and proceed the Amending of the Criminal Procedure Code Bill (No. ..) B.E. to the Cabinet for further consideration, within a sixty-day time limit before agreeing in principles.

4. Arbitration Bill (No. ..), B.E.

The President asked the sitting for allowing the Cabinet to proceed the Bill for further consideration before agreeing in the Bill principles within 60 days, as well as, demanded for quorum count before voting. Because of the lack of quorum, thus, the President ordered to adjourn the session.
